### Privacy Policy

Welcome to Chomee LLC ("we," "our," "us"). This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you use our mobile application "Chomee". Please read this policy carefully to understand our views and practices regarding your personal data and how we will treat it.

#### Information We Collect

We may collect and process the following types of information:

- a) Personal Identification Information: Name, email address, phone number, and other similar information.
- b) Content you create, upload, or consume within the App, including metadata, as well as your interactions with other users and the content within the App.
- c) Information about your device, including the device's unique device identifier, IP address, operating system, browser type, and mobile network information.
- d) Approximate location information, if you have location services enabled on your device.

We use the information we collect to:

- a) Provide, operate, and maintain the App. - Improve, personalize, and expand our App
- b) Understand and analyze how you use our App.
- c) Develop new products, services, features, and functionality.
- d) Communicate with you, either directly or through one of our partners, including for customer service, to provide you with updates and other information relating to the App, and for marketing and promotional purposes.
- e) Process your transactions and manage your orders. - Find and prevent fraud. - Comply with legal obligations.

#### How We Share Your Information

We may share your information in the following situations:

- a) We may share your information with third-party service providers to provide, maintain, and improve our services.
- b) We may disclose your information if required to do so by law or in response to valid requests by public authorities (e.g., a court or government agency).
- c) Business Transfers:\*\* If we are involved in a merger, acquisition, or asset sale, your information may be transferred as part of that transaction.
- d) With Your Consent, We may disclose your personal information for any other purpose with your consent.
- e) We use administrative, technical, and physical security measures to help protect your personal information. While we have taken reasonable steps to secure the personal information you provide to us, please be aware that despite our efforts, no security measures are perfect or impenetrable, and no method of data transmission can be guaranteed against any interception or other type of misuse

## Your Data Protection Rights

- f) Depending on your location, you may have the following rights regarding your personal information
- g) You have the right to request copies of your personal information. - The right to rectification
- h) You have the right to request that we correct any information you believe is inaccurate or complete information you believe is incomplete.
- i) You have the right to request that we erase your personal information, under certain conditions.
- j) You have the right to request that we restrict the processing of your personal information, under certain conditions.
- k) You have the right to object to our processing of your personal information, under certain conditions.
- l) You have the right to request that we transfer the data that we have collected to another organization, or directly to you, under certain conditions. If you make a request, we have one month to respond to you. If you would like to exercise any of these rights, please contact us at our provided contact information.
- m) Our App is not intended for use by children under the age of 5, and we do not knowingly collect personal information from children under 18. If we become aware that we have inadvertently received personal information from a user under the age of 18, we will delete such information from our records.
- n) We may update this Privacy Policy from time to time. We will notify you of any changes by posting the new Privacy Policy on this page and updating the "Effective Date" at the top. You are advised to review this Privacy Policy periodically for any changes. Changes to this Privacy Policy are effective when they are posted on this page.
